Contactless In-Home Appointment Restrictions

updated: 1/12/21

Lakeview Blinds Awnings & Shutters is registered as a Covid Safe Business.

The NSW Government has updated the rules and regulations around renovations in homes. We will be continuing renovations, repairs and maintenance in Newcastle, Maitland, Port Stephens, Central Coast and surrounding Local Government areas.

Works including renovations, repairs and maintenance (prescribed works) are allowed to commence provided the following COVID-19 rules are followed:

- In outdoor areas there is no cap on the number of outdoor workers at an occupied site.
- In indoor areas, no more than 2 people can undertake works at the same time
- If works are commencing in an indoor area, and other persons (e.g. members of the household) are present at the premises, they must stay in a separate area of the property from the consultant undertaking the works at all times.

During this time we kindly ask:

- Masks to be worn throughout your appointment
- Social Distancing during interactions
- If you have an outdoor/entertainment area, please direct our Sales Consultant to this space. Outdoor areas are more ventilated and Covid safe.
- If an outdoor area is not available our consultant will be in separate room from you whilst undergoing your appointment.

From the 11th October our Showroom is open.

To enter the premises the following is required:

- QR Code Check In
- Proof of Double Vaccination *this includes evidence from the Australian Immunisation Register that the person has had two doses of a COVID-19 vaccine; or a medical contraindication certificate issued to the person*
- Customer to be wearing a mask
- Sanitise hands
- Social distancing

There is a capacity on the quantity of customers allowed in the showroom at once, which is 14 people excluding staff.

An unvaccinated person under the age of 16 years must not be on the premises unless they are accompanied by a person who is a member of the person's household **and** are a fully vaccinated person.

These government guidelines will only apply until the 15th of December

From the 15th all members of the public will be welcomed.

Please note - a customer does not need to be fully vaccinated for us to attend site to quote or install.
